Dear Mr. McMullan:

Thank you for discussing with me the few issues that Pennell Place is confronting.

The issue that requires immediate attention is parking of vehicles on Bonsall Drive that runs from Cabot Court to Glenwood Drive.

Vehicle parking has caused Bonsall Drive to become one-way and seriously impacts visibility of traffic. We have several school busses pickup and discharge students at the corner of Bonsall and Glenwood and the trucks that park close to the intersection severely limit visibility and the ability of the bus to make the necessary turns.

When we spoke you suggested that the township erect No Parking sign(s) along Bonsall Drive. After deliberation, the Board of Directors has decided to support the township decision to erect a sign(s).

We believe that establishing this parking regulation will help with ensuring the safety of our residents. Please advise if the regulation will be consistent with chapter 235, paragraph 10 so we may announce the consequences if no parking is disregarded.


