PEDDLING AND SOLICITING LICENSE FEES

All applicants shall pay to the Township an Application License Fee in the amount of **\$200**.

All applicants shall pay an additional license fee of **\$150** for each employee, helper, or partner of the applicant who will be peddling or soliciting.

Where the applicant proposes to use any motor vehicle of any kind, including but not limited to a traveling store, store-on-wheels, or vendor of food products: **\$350** for each vehicle.

Each license shall be for the current year. No abatement of the annual license fee shall be made for any fractional part of a year, other than the annual license fee applied for on or after August 1 of each year, whereupon the said license fee shall be reduced to 1/2 of the original fee. All licenses shall expire on December 31 of the year in which they are issued.

I am familiar with all Ordinances controlling peddling and sale of goods and services within the Township and agree to strictly abide by their terms and conditions. I hereby certify that the statements contained herein are true and correct to the best of my knowledge and belief. I understand that if I knowingly make any false statement herein, I am subject to such penalties as may be described by law or ordinance, including revocation of this license.

I authorize you to obtain any information that you may require concerning statements in this application which shall remain the property of Middletown Township.
