Please be informed that the contractor is planning to close a portion of Manchester Road and residents can expect to see detour signage beginning today. A barrier will be installed at the intersection of Manchester and Knowlton Roads. The barrier layout plan is attached for your reference.

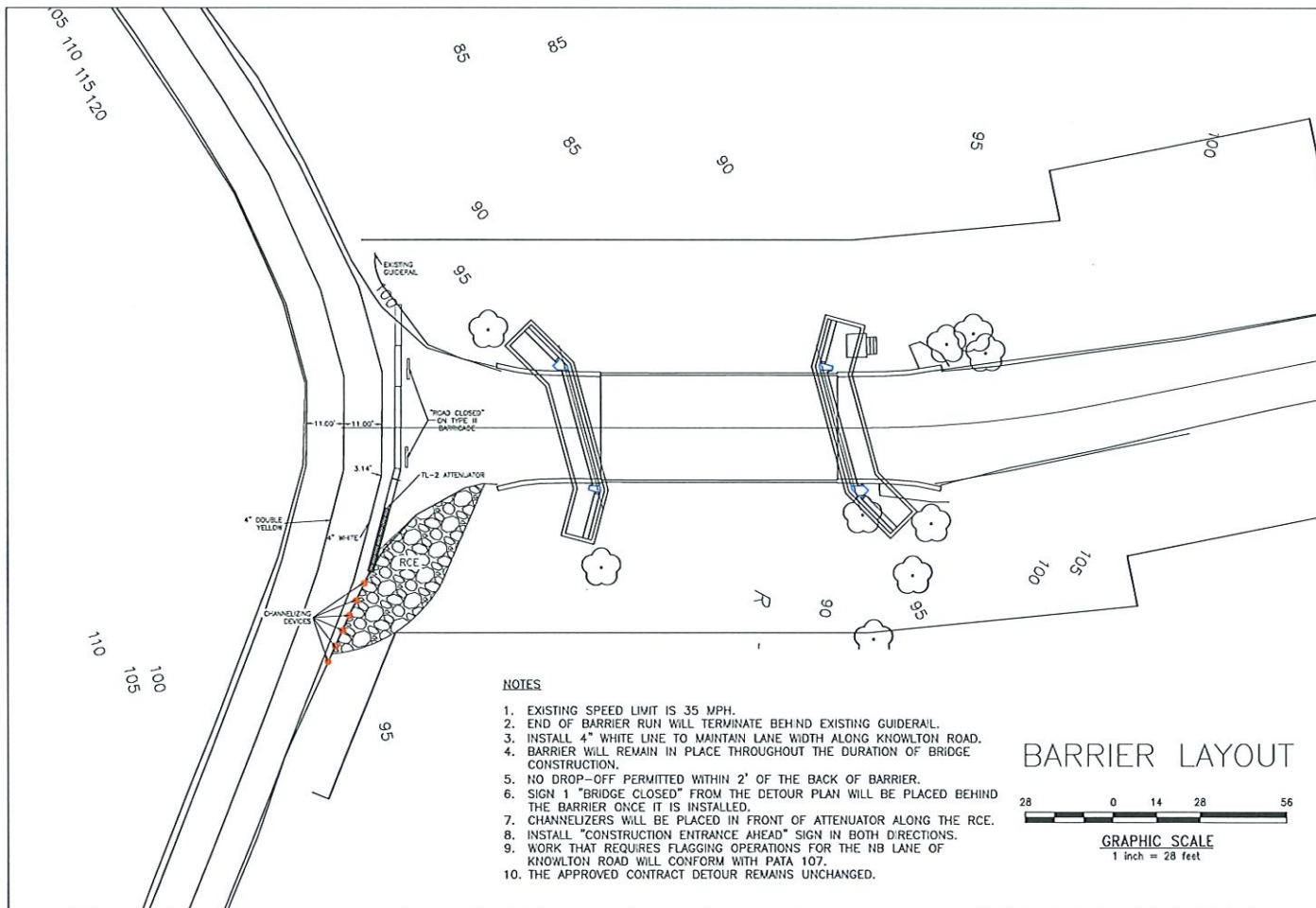
The project is anticipated to be complete by March 5, 2025. The County will be holding regular construction meetings and will share important updates with you as the project progresses.

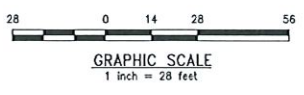

NOTES

1. EXISTING SPEED LIMIT IS 35 MPH.
2. END OF BARRIER RUN WILL TERMINATE BEHND EXISTING GUIDERAIL.
3. INSTALL 4" WHITE LINE TO MAINTAIN LANE WIDTH ALONG KNOWLTON ROAD.
4. BARRIER WILL REMAIN IN PLACE THROUGHOUT THE DURATION OF BRIDGE CONSTRUCTION.
5. NO DROP-OFF PERMITTED WITHIN 2' OF THE BACK OF BARRIER.
6. SIGN 1 "BRIDGE CLOSED" FROM THE DETOUR PLAN WILL BE PLACED BEHIND THE BARRIER ONCE IT IS INSTALLED.
7. CHANNELIZERS WILL BE PLACED IN FRONT OF ATTENUATOR ALONG THE RCE.
8. INSTALL "CONSTRUCTION ENTRANCE AHEAD" SIGN IN BOTH DIRECTIONS.
9. WORK THAT REQUIRES FLAGGING OPERATIONS FOR THE NB LANE OF KNOWLTON ROAD WILL CONFORM WITH PATA 107.
10. THE APPROVED CONTRACT DETOUR REMAINS UNCHANGED.
